




Big Box (300 x 250)


Custom Leaderboard (720 x 120)

Horizontal (225 x 45)


The horizontal banner appears on the bottom of all member (ie. internal) webpages making it one of the last things users see before going to another page of leaving the site.



INTERNAL MESSAGING


1. New message alert when user signs in on any desktop

2. Message available in user's Inbox


Once the user clicks the message alert icon on the dashboard it will open their Inbox and display the message subject, sent date and message type (i.e. announcement, promotion, notice, etc).
